

So far this fiscal year, (from 9/1/2000 to 8/31/2001) we have a total of 113 in full \$35 dues (\$3,955), 16 in \$10 dues (\$160 from the 1997-2000 delegates), partial dues payments totalling \$10 and another \$840 in extra donations - a total of \$4,965 for this fiscal year – which amounts to our cost of sending and mailing two newsletters a year.

# Report from the NYSF Board meeting

The National Youth Science Foundation Annual Board of Trustees meeting was held in Charleston, West Virginia on January 13, 2001.

Charles McElwee introduced the newest Trustee, John D. Rockefeller V. Chairman Hutchison noted that Trustee Eugene Kitts has resigned from the Board. Haywood McCallum led a moment of contemplation in recognition of Chuck Cochran, the first NYSC Director, who recently passed away.

Newt Thomas, Treasurer, reviewed the financial condition of the Foundation. An increase in costs is reflected in the new budget numbers. We were able to get onetime additional contributions from both the Daywood and Jacobson Foundations. The Adler Fund endowment is down 5% from a year ago and down 13% from its peak, due to market conditions, not withdrawals. Newt spoke with Stan Reynolds, our investment advisor, and they have decided to move from a growth to a value-oriented holding. The Adler Fund has yielded an average return of between 7 and 8%. That is reasonable for the type of fund that we have.

We have a challenge to bring in revenue, because we will not continue to be able to hold down costs indefinitely. Over the past several years we have held down costs, so we have produced the NYSC program for less than before in real dollars.

Next, Trustees Ron Pearson and Jill Cochran provided a report from the Program Planning Committee. The number one priority of the Program Planning Committee is the condition of the currently leased facility. This summer, the septic system nearly failed. There is not an adequate lecture facility. We are looking to begin new programs in 2002, and need to either find another facility or upgrade the current one.

Paul Miller presented the Director's Report for the 2000 NYSC.

Next, Zane Gresham reported on the Development Committee meeting. The Youth Science Leadership Institute of the Americas (YSLIA) program has recently become more timely. We have received funding through the State De-

partment for planning, but ran into fund-raising barriers similar to those experienced by the NYSC. The Summit of the Americas in April offers an opportunity for the Foundation to ask President Bush to extend an invitation to other heads of state to participate in an inaugural YSLIA program, although we may be too late to get in on this.

Nancy Gardner Hargrave, a fund-raising consultant suggested to us by the Fidelity Foundation, reported her findings to the Board. She noted that we need to listen to what potential funders who turned us down have to say. They will tell us what we are doing wrong, and in which direction we should head. She has worked with Darrin for about four months, and has helped him with several proposals. One of the problems we have is that there are more informal education programs now so competition is fierce. We need to change the model to expand the reach of both the current national program and the proposed YSLIA program. Many of the organizations that rejected our requests pointed out that our program was not aligned with the NSF's science standards, so we need to look into that. We need to get a panel to come in, review our programs, and make recommendations, and we will use part of the \$25,000 challenge grant from Fidelity for that purpose.

Erica Umback reported on the activities of the National Youth Science Camp Alumni (NYSCAA) Association. We are close to getting the alumni database on a secure web server, where it will be accessible by alumni and Foundation staff. Karen Sabog is the webmaster and has arranged for the service. The annual business meeting of the NYSCAA will be held in Colorado in early August.

The meeting moved into Executive Session. Trustees George Bennett, Haywood McCallum, Elizabeth Chilton, David Hackleman, Martha Wehrle, and Cuong Do (subject to his acceptance) and John D. Rockefeller V were elected to three-year terms. Current officers (Joseph M. Hutchison, Chairman; Zane Gresham, Vice Chairman; Charles McElwee, Secretary; and L. Newton Thomas, Jr., Treasurer) were reelected to serve a one-year terms.

The Senate Luncheon will be Thursday, July 19, 2001. Chairman Hutchison will decide on the time and location of the Board meeting. David
